Liability

1. Pathfinder Parachute Group Ltd shall provide parachutists with the opportunity to parachute during one of our training courses and events in Normandy and Arnhem.
2. The parachutist affirms they choose to jump at their free will, without reliance on Pathfinder Parachute Group or implied persuasion, information or suggestions regarding the parachute jump.
3. During the time of the jump, there may be other persons jumping who shall not be supervised
4. Parachutists shall follow the rules and guidelines provided by Pathfinder Parachute Group Ltd.
5. Parachutists confirms their consent with these rules and guidelines by signing a copy of this Waiver, which remains with Pathfinder Parachute Group Ltd.
6. The jumps shall be provided after the Parachutist has signed this Liability Waiver.
7. Pathfinder Parachute Group Ltd may provide parachute equipment for use, and shall ensure that the equipment is serviced and packed to normal safety standards.
8. Pathfinder Parachute Group Ltd shall bear no liability whatsoever for consequences due failure of the parachute equipment.
9. Parachutists shall provide clothing and accessories that are necessary in order to complete a safer parachute descent.
10. All clothing and accessories must conform to published criteria within the operations order.
11. Pathfinder Parachute Group Ltd may offer to parachutists Instructor's advice on acquiring, retaining, and improving parachuting skills and techniques. Parachutist shall apply Instructor's recommendations at parachutists own discretion only if the parachutist is certain that they have understood the advice and is certain about their ability to successfully perform it.
12. Pathfinder Parachute Group Ltd shall have the right, and not the obligation, to refuse the parachutist if he/she does not follow the requirements provided in the Rules of recommendations, especially the requirement not to be intoxicated with alcohol or drugs.
13. Parachutists must be aware that by taking part in Pathfinder Parachute Group Ltd activities that they are at risk of traumatism. Parachutists upon their discretion may acquire insurance cover against the damages to their life, health, and property resulting from the jump.
14. Parachutists are is aware that their current life, health and/or liability insurance coverage may exclude risks that are related to the use of parachuting, and that third parties may be refused insurance payments for the damages resulting from a parachute jump.
15. Pathfinder Parachute Group Ltd shall bear no liability whatsoever for the quality of the parachutists acquired skills and for consequences of the application of such skills in the parachutists other activities.
16. TO THE MAXIMUM EXTENT PERMITTED UNDER THE APPLICABLE LAWS, PATHFINDER PARACHUTE GROUP LTD SHALL BEAR NO LIABILITY WHATSOEVER FOR A PARACHUTISTS INJURIES, TRAUMAS, AND OTHER DAMAGES TO PARACHUTISTS HEALTH, PROPERTY, AND LIFE, INCLUDING PARACHUTISTS DEATH, NOR FOR DAMAGE PATHFINDER PARACHUTE GROUP LTD HAS CAUSED TO THIRD PARTIES DURING THE FLIGHT OR JUMP. PARACHUTIST HAS DISCUSSED THIS CONDITION WITH PATHFINDER PARACHUTE GROUP LTD AND HAS AGREED WITH IT.
17. TO THE MAXIMUM EXTENT PERMITTED UNDER THE APPLICABLE LAWS, PARACHUTISTS WAIVES ANY AND ALL CLAIMS THAT THE PARACHUTISTS HEIRS OR SUCCESSORS MAY HAVE AGAINST PATHFINDER PARACHUTE GROUP LTD, ITS OFFICERS OF PATHFINDER PARACHUTE GROUP LTD PERSONNEL IN RELATION TO USE OF THE FLIGHT AND PARACHUTE JUMP.
18. **Parachutist give permission for Pathfinder Parachute Group Ltd to use all media (Photos and Videos) for marketing and social media content.**
19. **If the parachutist does not want photos and videos being used, it is their responsibility to inform Pathfinder Parachute Group Ltd during all photo shoots, presentations and jumps so Pathfinder Parachute Group Ltd can support your wishes.**

I have been informed by Pathfinder Parachute Group Ltd that it is my responsibility, and I accept that responsibility to purchase travel insurance which must include liability and repatriation for parachuting activities.
